Sherie LaRue 2nd the motion. Motion passed. None opposed.

Laurie Guthrie made a motion to remove the last sentence in the revised paragraph "No reimbursement shall be given in June". Motion passed. None opposed.

Arin Tempke made a motion to move this by-law change as written to be voted on by the general membership at the May 10th meeting.

Kevin Luce 2nd. Motion passed. None opposed.

1st Reading, Constitution addition Article, IV, section 5(c) - Terms, Powers and Duties of the Officers for Treasurer.

Rick Morgan made a motion to change the yellow highlighted paragraph to match the President's in reference to the membership number changing from 630 FTE to 60% FTE of membership to be decided at the December and May Executive Board meetings.

Kevin Luce 2nd the motion. Motion passed. None opposed.

Laurie Guthrie made a motion that this proposal be brought to vote at the May 10th General Membership meeting.

Kevin Luce 2nd the motion. Motion passed. None opposed.
